## Albrecht's Pride and Joy



Congrats from all of us! We hope he continues his success!








## Tyson and Chrissy at work

Sarah opened her front door to find a small ball of fur on her snow-covered mat. As she stood staring at whatever it was, it turned and looked up at her. Sarah immediately realized it was a small dog, apparently lost and certainly

freezing in the huge snow storm. Not giving it a second thought, Sarah reached down, scooped up the limp dog, carried it into the kitchen and set it down on a blanket. To her alarm, the little dog was not just limp and exhausted but seemed to have no energy and, even worse, no interest in anything.

Sarah decided she couldn't chance waiting. She wasn't sure that "Little One" was going to make it at

all. Sarah bundled her up and rushed off to the vet to find out what, if anything, could be done.

It took a good week with special meals, antibiotics, and lots of TLC, but Lily, as she's now known, went from freezing and semi-comatose to being a bright, active, and happy Sheltie-girl learning to live indoors in a warm household.

Next on Lily's agenda was potty training. A 10 pound Sheltie, probably between 11 and 13 years old, is now a mostly house-trained, 12 pound Sheltie.

Sarah and her family took on the enormous task of saving a life. Lily gave them her love and devotion in return. Thanks to Sarah (who couldn't keep Lily) Lily is alive and well and is now part of the Sheltie Rescue of Utah program.



## ■ Last Minute Intervention Halts Euthanasia

John was worried. Something was wrong with his cat. As John sat in the waiting area of the veterinary clinic he noticed a woman with a frightened dog. John struck up a conversation with her and discovered she was there to have Matty euthanized. Matty's Mom and Dad had moved into a nursing home a year ago and then passed away. Nobody in the family was willing to care for Matty.

John was so distraught at the idea of killing a dog simply because nobody would take responsibility



for its care that he could barely speak. When he did, it was to say, "Oh no. There must be some way we can save this dog." The vet's staff provided John with Sheltie Rescue's phone number. John was soon talking with Caren Ciampini. John arranged to cover all boarding and medical expenses if Sheltie Rescue would bring Matty into our program and find him a home. John generously paid a hefty bill for Matty who needed eighteen teeth pulled. Matty, whose life was saved by John's last minute intervention, is now seeking a home through Sheltie Rescue.

- 1. Meeting was called to order at 7:07 pm, who read the Agenda, which was approved.
- 2. Various announcements: the Holiday party was very successful; there are newsletter delays due to computer problems; calendar of events will be updated for the next several months.
- 3. Minutes for previous meeting was read by Caren; Marie moved & Ernie 2<sup>nd</sup> that they be approved; motion carried.

## Ray's "Bandit", A Lucky Family Friend

I feel compelled to share with you all the story of "Bandit". Don't worry, he's still very much alive and a very big part of the Stapp family.

What's special about "Bandit" is that

he is such an integral part of the Stapps.

When first approached by Ray to purchase a puppy, I thought it was a grand idea and had



seen Ray frequently in the groom shop with his Grandmother Florence and her old dog "Gigi" now waiting for her at the bridge. Ray told me how he had owned a sable sheltie before and now having seen my Harley at the shop, he voiced a resonant desire to have a sheltie that looked just like

Harley. Well, I had a "Corey" litter about that time out of one of Don Bickford's sires and lo and behold one of those puppies was a bi-blue with a perfect checkerboard face. I knew that puppy

was meant for Ray.

All the bloodwork had been done, everything that would tell them at least he hadn't been poisoned.

Ray came to the house and with his special sweet Grandmother, together they took Bandit home.

Bandit quickly took over the house and family. They included him in everything from what they would tell me. A bit overindulgent in his diet, and always, always trying to do the right thing with him, life seemed great.

Bandit had his moments of worry, like as a year old, he ran the fence so

hard (as our shelties are so famous for doing) that he was found after a hard limp one day to have a stress fracture in his hip. They babied him along with that, it healed, and it didn't

> slow him down one bit. He went off to the mountains with them, he went to the desert, he went fishing, he went traveling to and fro, from here to Timbuktoo! Still does!

One day I received an alarming call from Ray. He asked whether seizures was

known in my lines. I knew of no problems and was mortified to learn that Bandit was very sick and seizing. All the tests had been ran, the bloodwork, everything that would tell them that at least Bandit had not been poisoned. They tried in vain to stop his seizures and ruled them to be "idiopathic" in nature. Meaning they had no idea the cause. We fretted as I saw Bandit slide from a happy active youngster to a near dead suddenly old looking and very miserable dog. They maintained him on Phenobarbitol or Sodium Bromide, the drugs of choice to treat seizures in dogs.

One thing that always bothered me was that Bandit seemed to always have a bit of a stuffy snotty nose. This just isn't normal, but he was being treated and they were doing all it seemed possible.

I thought, when I gave him a bath one time, that "This may be his last groom, he looks terrible", and I felt that Bandits quality of life had dwindled away and that his very life was in danger it seemed, then, something miraculous happened.

We don't know the exact cause or rea-



son, but whatever was causing that bad nose,

the green discharge, whether it was a June grass that had migrated to his sinus's or, whether he had gotten an abscess high up in his sinus cavity, causing an immense amount of pressure on his brain, whatever it was, suddenly and miraculously broke. Just when death was whispering his name. It broke. It drained. He lived. He lived!

Bandit is again the dog he was meant to be. No more seizures, not one from that day forward. He was removed from all medication, his coat glossed up again, he regained what seemed like years to his demeanor. Bandit, like a cat got another life. A second chance was granted.

I hear again the stories I look forward to hearing, about his wonderful life as the companion he was meant to be.

Each puppy I send out the door is special, each one unique. Bandit doesn't care one iota for his Grammy J" as I



like to refer to myself to puppy buyers. He is busy living his second

chance life. My special checkerboard dog. When Ray brings pictures to me of all their travels and tells me how much they do with Bandit, it gives me a thrill.


I hope miracles can be there always for our dogs. I thank God there was one there for him. ways a miracle.

There are many, many ways to make delicious, nutritious and fun snacks and treats for your darling four legged spoiled kids! After just a short search on the internet, I found so many, but the ones below looked terrific and easy to make. With so many choices of dog treats to purchase at premium prices, making treats may have seemed a bit extreme just a short time ago, but no longer! Now we know that the many chemicals, food colorings and preservatives used in commercial dog treats may look appealing to the buyers, but, they hold little nutritional value for our pets. Take a few moments and make a

worthwhile treat for your pets.

#### GARLIC AND CHEESE Dog Cookies

1/4 cup cheddar cheese, grated
2 Tbs. safflower oil
1/2 cup Rice Krispies cereal
1/2 tsp. ground garlic
1/4 cup swiss cheese, grated
Combine cheeses, garlic and oil.
Using plastic wrap, shape mixture
into a log about 1 inch in diameter
and 8 inches long. Roll log in Rice
Krispies. Refrigerate. Slice into
half-inch rounds and serve.



## Bad Breath Banishers

- 2 cups brown rice flour
- 1 Tablespoon activated charcoal (find this at drugstores, not the briquets!)
- 3 Tablespoons canola oil
- 1 egg
- 1/2 cup chopped fresh mint
- 1/2 cup chopped fresh parsley
- 2/3 cup lowfat milk

Preheat oven to 400F. Lightly oil a cookie sheet. Combine flour and charcoal. Add all the other ingredients.Drop teaspoonfulls on oiled sheet, about 1 inch apart. Bake 15-20 minutes. Store in airtight container in the refrigerator.
