Something to think about with our up coming specialty.

Fellow USSA members,

We are all aware that the ASSA holds a National Sheltie specialty each year that includes not only conformation classes, but also obedience, herding, and agility --- performance events. Last year, of course, we hosted the National ourselves. This year, it's being held in St. Louis and I know some of you are planning to go.

I am the lucky guy this year who is responsible for soliciting donations for performance event trophies at the 2005 National. The Sheltie community has been generous and there are only a 8 obedience trophy positions that have not been filled, plus 13 herding trophy positions not yet taken.

To my surprise, considering how extremely popular agility is, donations for the agility classes have been lacking. I have no fewer than 23 unfilled trophy slots in the regular classes and a disappointing 35 in the jumper classes. The preferred regular and jumper classes have had only one donation at all, leaving 64 unfilled trophy places.

I have to submit all of the donations, information, etc. regarding performance trophy donations to the ASSA in about 10 days.

I ask for you to come through for the National Sheltie Specialty and to donate some of the remaining trophies. First places are available for \$35, second places for \$30, third places for \$25, and fourth places for \$20. In return for your donation, you get to specify a dedication or other message up to 60 characters and spaces in length; that text will be printed in the catalog next to the listing of the trophy.

Please consider donating a trophy for the obedience, herding, and especially the agility classes for this year's National. Getting more donations will be very helpful in ensuring that the ASSA continues offering performance events in future Nationals. Here's what's still needed:

We learned a lot about how immunity is formed and the kinds of things we should be vaccinating against. Dr Law is also an expert in animal orthopedics. He talked to us about hip dysplasia and x-ray screening to detect dysplasia in our dogs. We discussed Penn

Hip x-rays as compared to the OFA x-ray. The discussion was very interesting and informative. Anyone wanting to see Dr. Law can make an appointment to see him at the Cottonwood
