

## I Have a Question....

#### This Month's Question:

What are the best shampoos and conditioners to use on my sheltie's coat. Is it bad to use human products? Is there a shampoo and conditioner that I can get locally that will work well? What other products should I consider to keep my dog's coat pretty?

Ok, I have corgis and shelties, but use the same things on both of them.



These products aren't available locally though. For general bathing the Maine and Tail products you can get at Wal-Mart (pet dept.) work well.

I don't use conditioners on Corgi coats as we want them to keep the harsh texture, so I'll leave that

part to those with more sheltie experience. —Peggy Newman

As far as washing dogs, I use horse products from IFA. called white and bright and add bluing to it on white dogs. For really dirty jobs I use a soap called grime e nator and it is shipped to me and makes 2 gallons from a 4 oz. bottle. and smells good. I have also heard that feeding your dog dark molasses will get the purple out of a dark dog. Don't know if it is true or not. —Tomi Hamblin

Since human and dog skin pH is different, and since shampoos and conditioners are pH balanced, these products should not be interchanged - using human products on dogs. Last month's Q&A had more info on this. —Kay Miller (with info from Kris Muscari, DVM)

Next Months Question: I want my new puppy to have nice ears like the ones that I see in show dogs. What do I need to do to keep my puppies ears tipped? When is the best time to train the ears? When is it too late to train them? What products do you use to train them?

## **RECIPE OF THE MONTH:**

#### **Peanut Butter Logs**

2 cups dry dog food

2 packs cream cheese

1-1/2 cups peanut butter

1/2 cup corn oil

1 cup cottage cheese

1 pound browned hamburger



Blend dog food (crushed fine in a blender) and add remaining ingredients. Mix (kneading with your hands) till you have a doughy mixture. Add more dog meal as needed if consistency is to thin. On wax paper spread some meal and roll out mixture into a log shape. Refrigerate logs until firm and slice as needed. Feed them a slice or two several times during the day. Very high calorie......will put weight on fairly quick.

#### An Article of Interest for Sheltie Owners

## 10 Ways to Improve Your Winning Percentage in the Conformation Ring by Anne Bowes

In the national pastime, baseball, players are constantly evaluated in terms of percentages: batting averages, earned-run averages, and so on. Our favorite pastime, that of showing dogs, does not measure success in terms of percentages, even though the sport does lend itself to that type of comparison. For example, instead of reporting just the number of Bests in Show a dog wins, wouldn't it be more enlightening to know how many shows it took to reach that number? Obviously, a dog who wins 10 Bests in 20 shows is a better dog than one who wins 20 Bests in 100 shows. A stud dog who produces 10 champions in five litters is more valuable than one who has produced the same number in twice as many litters.

Some years ago, I began keeping yearly statistics on my winning percentage in the conformation ring. I calculated how many times my dogs are Winners or better and divide that by the number of shows I attend. Over the years, I have learned whether my performance in the ring is improving, staying the same, or deteriorating. This helps me plan my strategy for the next year.

Whether you are just starting out on your showing career or have been at it for a while, here are some ideas that help improve your winning percentage in the ring:


- 1. **Find a mentor.** Everyone who wishes to be successful in the sport of dogs needs a mentor. Hopefully, there are one or two experienced breeders in your breed to whom you can turn for help with solutions to the many problems one can encounter when breeding and showing dogs. Listen carefully and discuss your decisions with your mentor. Even those of us who have been breeding and exhibiting for many years need someone to act as a sounding board for the many complex situations we face.
- 2. **Start with the standard.** A thorough understanding of the standard for your breed is imperative if you wish to show and breed dogs successfully. Attend seminars on your standard and discuss the fine points with experienced breeders. Make sure the dogs you are showing are good examples of your breed and conform well to the standard.
- 3. **Conditioning**. It is useless to show dogs who are overweight, underweight, or in poor coat. Even if you have the better dog, if he is out of coat or not as fit as your competitors' dogs, your chances of winning are reduced.
- 4. **Training.** Dogs who perform well in the show ring win more than those who don't, even though the untrained one may be the better dog. Judges do not usually have time to struggle with a dog who does not want to be in the ring. Handling classes are a *must* for serious exhibitors.
- 5. **Research judges**. Research is necessary to decide which judge to enter under. The Internet is a wonderful way to track the history of many judges. Some judges routinely take their winners from the Open class, while others will often give the points to a promising puppy. Try to enter under experienced judges who have good hands-on knowledge and a reputation for being fair, thorough, and competent.
- 6. **Be prepared.** Most kennel clubs will allow you access to the show site the night before the show so that you can set up your crates and grooming table near your ring. On the day of the show, arrive early, at least two to three hours before your ring time. After you have settled in and prepared your dog, leave your dog in a crate and go over to your ring to get the "lay of the land." Pick up your number and then stand and watch your

judge for the day go over the breeds ahead of yours. Notice her judging pattern and make mental notes about what she seems to be looking for. Figure out how your judge is using the ring and notice any problems you may need to avoid, such as getting stuck behind the table or a column.

- 7. **Combat nerves.** A case of serious butterflies can really take a toll on you and your dog's performance in the ring. Do whatever you can to settle your nerves—take deep breaths, chew a mint, smile at your dog, and try to relax. Concentrate on the task ahead of you, and avoid getting into long conversations with other exhibitors or spectators just before going into the ring. Focus on what is happening inside your ring and be ready when your dog is called.
- 8. **In the ring.** The moment you walk into the ring, you are "on stage" and your entry fee starts ticking away! Walk into the ring as if you have the best dog there, and keep up that attitude the entire time you are in the ring. Timing in the ring is very important. Make sure you are always showing off your dog's virtues to their best advantage at the exact time the judge is looking at those virtues. The judge is not the only one you want to impress. Standing ringside may be your peers, your future clients, and your future judges who are watching your performance and sportsmanship.
- 9. **Postmortem.** What happens after you leave the ring might well determine how well you do next time outor even if you continue in the sport. Win or lose, you should spend some time assessing your performance in the ring. Figure out what happened. If you made some mistakes, don't worry about them, just learn from them. If your dog misbehaved, train, don't complain! Set goals for yourself, both long-term and short-term, and then assess how you met those goals. Set new goals for the next show.
- 10. **Enjoy yourself.** Remember to have fun! Enjoy the camaraderie with your fellow competitors, and enjoy your time in the ring with your dog. We are truly fortunate to be a part of such a fantastic sport!

#### Sweetener Alert

NEW YORK (Reuters) - Keep those sugarless treats out of Fido's reach. Veterinarians warned on Friday that a commonly used sweetener might cause liver failure in dogs, and perhaps even kill them.

Their report in the Journal of the American Veterinary Medical Association appears to strengthen the suspected link between the sugar substitute xylitol, thought to make dogs sick, and possible liver failure.

Xylitol, a naturally occurring product, is found in many sugar-free chewing gums, candies, baked goods and toothpastes.

Researchers Sharon Gwaltney-Brant and Eric Dunayer with staff at a poison unit of the American Society for the Prevention of Cruelty to Animals in Urbana, Illinois, gathered information on eight dogs treated between 2003 and 2005 after eating products containing xylitol.

Each dog became ill, and five died or had to be put down because of liver failure, possibly from ingesting xylitol.

One dog who had to be euthanized had eaten four large, chocolate-frosted muffins containing about 1 pound (0.45 kg) of xylitol.

People don't think sugar-free gum can kill their dog. I didn't before I got into this. But this is something people should be aware of," Gwaltney-Brant, who co-authored the study with Dunayer, said in a statement.

Gwaltney-Brant said for dogs, ingesting even a small amount of xylitol can trigger significant insulin release, which drops their blood sugar and can be fatal.

"A 22-pound (10-kg) dog who consumes one gram (0.03 ounces) of xylitol should be treated," she said, adding that further studies were needed to definitely establish a cause-and-effect relationship.
