# Speaking of a Healthy Dog

We are for the most part in our group, an educated lot. We have been around and cared for dogs for the majority of our lives in most cases. We certainly consider ourselves to be a bit more knowledgeable than the average Joe when it comes to dog ownership. We must know then, as educated people, that there's always room for more knowledge!

I was visiting with Dr John Whiteley whom I have been employed with at Alta Groomery for the last 12 years now concerning some of the most common health problems he has observed over the recent years. Lisa, the office manager there felt, as I have heard from Dr Whitely, that certainly topping the list of most common things seen at the clinic were ear infections. Thankfully that isn't the most common health issue with our darling Shelties. Second to that were dental problems. As a consequence to that conversation, I thought I'd share some things I've learned over the years.

Not a single breed mixed, purebred or otherwise has escaped the massive destruction to overall health created by poor dental hygiene in a canine. It starts innocently enough with either a retained canine in puppies, or perhaps after a year or so, we stop checking the condition of the teeth. Time gets away from us fast and so the tarter builds up. Following the tarter build up, we see that the gums get slightly enflamed, then the whole gum line is red, with a more pronounced tarter and plaque builds up. The breath is pretty "doggy" and we are less apt to get in the dogs face for kisses like we did when they washed our faces with sweet puppy breath.

Once that tarter is built up around the teeth along the gum line, the gums tend to swell over the top of the edge of the tarter obscuring the destruction beginning. The bacteria under the gum line against that tarter dam begins traveling up the root of the tooth; it creates a by-product of toxins, which must be filtered from the blood by the kidneys and liver. Acid and bacteria begin eating away at the root of the teeth, which creates odor. The dogs' organs are compromised along with the heart, which tends to build up the plaque around the heart muscle and the progression of the dental disease builds. Soon we find loose or missing teeth, kidney and or liver disease, and the effects on the heart can reduce life expectancy and quality of life. The dogs' mouth may be in pain to varying degrees.

Certainly we have found that brushing teeth every day will reduce and even eliminate, for the most part, the progression of this insidious thief of a dog's overall health. The food we feed can also make a difference. A dog that is fed canned food is more likely to develop dental disease earlier. There are dog foods designed to address dental health such as, for example, Science Diet manufactures a prescription food called TD which is designed to scrape a dogs teeth, cleaning it of building plaque and tarter over time by not breaking up so easily. This is one solution, but the dog must need the specific nutritional recipe provided by that food to be utilized best for the dogs overall health. There are a variety of dog chews, which help exercise, the dogs' jaws and clean the dogs' teeth, but one must be vigilant about making sure that we aren't giving them chews which may not be 100 percent digestible and which may cause intestinal blockages. There are movements, which promote giving raw turkey necks or raw chicken wings or backs as a means to remove and prevent tarter build up. These may be very effective but must be administered with great caution to prevent other immediate health issues such as choking, diarrhea, pancreatitis, broken teeth, and punctured or blocked intestines. These are extremely serious health risks and should be discussed with a Veterinarian prior to using them, but may also offer real solutions to an ongoing life health concern.

In all seriousness, the teeth of our dogs must be attended to just as carefully as our own. We have learned that dogs that build up a serious tarter issue quickly are dogs that very often have compromised immune systems. The need to understand the urgent nature of dental health of our dogs cannot be stressed enough. Carrying out a well-designed dental health program suited to each dog's individual needs can greatly affect their quality of life and can mean adding years of quality of life time to your darling sheltie. Our shelties are somewhat prone to these dental health difficulties so don't feel your dog may be immune to the problems. Be proactive with oral care and maintenance and make their life easier!!

## I Have a Question....

**If a bitch has given birth to litters that have two puppies in each litter, will the size of her litters influence the size of litters her female puppies will have?**

**Answer:**

*The answer to this in my opinion is yes and no. Litter size is dependant on a number of things. It may be a particular bitch has small litters as a general rule, and she could pass that tendency on to her daughters.*

*However litter size is also dependent on the age of the bitch, the nutrition of the bitch, the health of the eggs she produces, and the health and number of the sperm the male she is bred to produces. In the Book "Raising Healthy Puppies" put out by the lams company Russ Kelley, MS states that litter size is dependent on not only the breed of dog, but also the age of the dog. Shelties, he says, have an average litter size of 4 puppies and the number of puppies in a bitch's litter start to decline in the sheltie after age 4. The critical age when litter size really starts to decrease in the sheltie is after age 8. A bitch that is under a year of age will also typically have a decrease in litter size. Heredity seems to play a part in litter size, but remember that the sire also contributes genes to his daughters and so contributes to the gene pool of all female puppies in the litter as well. If the sire does not have a good sperm count, or the sperm are not healthy that can also reduce litter size. Males also lose sperm count and motility as they grow older or if they are very young.*

## RECIPE OF THE MONTH:

### Cheese N Garlic Bites

1 cup wheat flour  
1 cup grated cheddar cheese  
1 tablespoon garlic powder ( not garlic salt!)  
1 tablespoon soft butter or margarine  
1/2 cup milk

Mix flour and cheese together. Add garlic powder and softened butter. Slowly add milk till you form a stiff dough. You may not need all of the milk. Knead on floured board for a few minutes.

Roll out to 1/4 inch thickness. Cut into shapes and place on ungreased cookie sheet. Bake 350 degrees oven for 15 minutes. Let cool in oven with the door slightly open till cold and firm. Refrigerate to keep fresh.

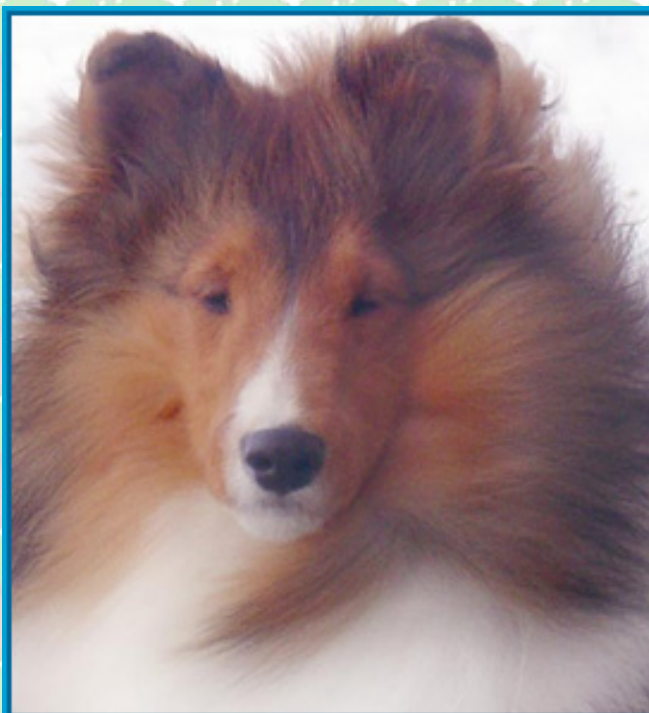

**1. WELCOME:** Tricia welcomed those in attendance and called the meeting to order at 5:56 P.M.

**2. AGENDA:** Doug Sorensen made a motion to accept the agenda as written. Judy Williamson seconded the motion. The motion passed. 7-0-0

**3. BOARD MEETING MINUTES:** Judy Williamson made a motion to accept the board minutes as written. Doug Sorensen seconded the motion. The motion passed. 7-0-0
