Latest laws, hotline mark puppy mill action week

vIndianz.com (Dec. 07, 2009) — There was abundance of action this past week throughout the Humane Society of the United States' "Puppy Mill Action Week."

Here's a little of the news: HSUS launched a national "puppy mill" tip line to persuade public to report brutality in money-making breeding amenities. The hotline, 1-877-MILL-TIP, is open to anybody with information of a probable crime concerning puppy mills.

The action week coincides with the beginning of the holiday shopping season. Most animal welfare groups have the same opinion that giving pets as gifts is usually not a good idea, in case they end up being returned to a store or discarded at a shelter. But if somebody on your Christmas gift list has put a pet at the top of their list, animal welfare groups say, think adopting from a shelter to a certain extent than buying from a pet store. Facts show the majority of pet shop puppies come from great commercial breeding kennels.

To illustrate that point the HSUS previous week released a video interview with a puppy mill whistle blower – a Virginia man who worked at numerous commercial kennels where he says dogs were regularly shot or beaten to death for being sick or infertile. Those that survived, he said, were forced to live outside in crude

boxes overflowing with their own waste.

In other news from the frontline of the nation's puppy mill wars, Wisconsin became the tenth state this year to enact legislation to clean up commercial kennels. The Wisconsin Commercial Dog Breeders Licensure Bill requires huge commercial breeders and animal shelters to be approved by the state and sets least amount standards of essential humanitarian care and provides for usual inspections to ensure obedience. The measure targets just large-scale facilities and does not be relevant to small breeders who sell lesser than 25 dogs in a year.

And, a small community in the scenic Finger Lakes region, southeast of Rochester, New York, previous month took what may be the strongest step any municipality has taken to curtail puppy mills: they debarred them completely. The town of Romulus at present requires pet breeders to give humane housing for dogs and cats and make sure that such animals are treated appropriately. It also restricts kennels to industrial zones, mandates periodic inspections and penalties for ruthless treatment.

"It has been accepted in the press that dogs rescued from puppy mills display a extensive range of veterinary and behavioral problems," town supervisor David Kaiser told the Finger Lakes Times. "Given the warning to both animal safety and public health, I'm proud of the effort of the town to fight this problem."

The council took action after enacting a nearly two-year-long moratorium on commercial kennel construction.

HSUS Update

The HSUS now is putting their misleading advertising (for donations) on ABC, CBS, NBC, the History Channel, ESPN, Animal Planet and possibly some I've missed. They appear to be getting stronger while we're getting weaker. We do know the HSUS plans a big legislative push at the beginning of 2010. The HSUS had a lot of legislative wins in 2009 and very few defeats.

A number of people have put together a campaign to ask the IRS to investigate the HSUS on their non-profit tax status. This campaign is now underway and is ready to go public. The campaign is called: "**How to Spay and Neuter the HSUS**"

Among others, the originator of this campaign is a retired Air Force lawyer in Missouri who is a member of Missouri Federation of Dog Clubs (MoFed). He's also been a lobbyist in Washington for a number of years and knows how the system works in Washington D.C.

The plan is to send a one-page certified letter to the IRS to investigate the HSUS. The certified letter receipts are then to be mailed to Frank.

The timing of this campaign has been carefully planned for the time between Christmas and New Years. The reason is because the HSUS will be able to respond before the campaign is already underway and the IRS has already been put on notice.

We then will send a request to investigate the HSUS to our individual state Senators and Representatives. Then Frank will actually go to the IRS headquarters, with all the certified receipts in hand, and demand that the investigation begin. Our letters to our Senators and Representatives should prompt at least some of the legislators to also demand action by the IRS.

This is the latest e-mail I received from Judy Kelsey, a Sheltie breeder and judge who lives in Florida or Ontario, Canada depending on the time of the year. She's the person who got me on board this campaign.

UPDATE ON "HOW TO SPAY and NEUTER THE HSUS":

Mr Frank Losey reports that he has received confirmation from 34 states that have already sent in certified letters to expose the HSUS to IRS. More from these states is certainly welcome. THANK YOU all for doing this carefully-timed event at this busy time of year.



Sportsmen's & Animal Owners' Voting Alliance

USSA article for December 2009

I thought for this month I could give information on one of the organizations we can use as a resource in the fight against animal rights legislation. It's called the Sportsmen's & Animal Owners' Voting Alliance (SAOVA) <u>http://saova.org/index.html</u> and along with such organizations such as the National Animal Interest Alliance (NAIA) <u>http://www.naiaonline.org/</u> can be of great help when we need information.

Anti-Hunter/Animal Rightist Political Action Committees (PACs)

One of the most effective methods the anti's have to promote their legislative initiatives against hunting, breeding, entertainment, meat eating, or any other use of animals is through their *"political action committees"* (PACs), of which the largest and most visible at the federal level is Humane USA Political Action Committee. Its members include The Humane Society of the United States (HSUS), The Fund for Animals (FFA), Farm Sanctuary, ASPCA, Doris Day Animal League (DDAL), Animal Welfare Institute, The Ark Trust, Animal Rights Foundation of Florida, and others. DDAL and FFA recently merged with HSUS, making the latter not only the wealthiest and best organized of the animal rights advocacy groups, but Humane USA's chief client. A HSUS employee has always directed Humane USA.

In addition, a host of smaller state PACs also network, lobby legislation, endorse and fund candidates. The oldest of the state-level PACs is the extremely active California Political Action Committee for Animals (PAWPAC), which is ten years older than Humane USA. Other increasingly active anti-sportsmen and animal owner PACs include: Humanitarians for Environmental and Animal Laws (Michigan), Pro-Animal PAC of Colorado, Humane/Oregon PAC, Animal Advocacy Connecticut, Animal Protection of New Mexico/Animal Protection Voters, Louisiana League of Humane Voters, League of Humane Voters of New York City, League of Humane Voters of Ohio, League of Humane Voters of Central Pennsylvania, Animal Defenders of Westchester, Humane Voters Council (Washington), Animal Protection PAC (New Jersey), Colorado Humane Voters League, North Carolina Voters for Animal Welfare, Virginia Voters for Animal Welfare, Nevada Voters for Animal Welfare, Animal Legislative Action Network (California), and Farm Sanctuary (New York and California).

A very important link on the Sportsmen's & Animal Owners' Voting Alliance (SAOVA) page is the link which lists which representatives in your state are SAOVA endorsed or are animal rights endorsed and/or funded.
